How To Use This Form

Completion of the form will give the signatory access to download one or more datasets from ADA's Restricted Access collection. Separate processes are required for general access datasets.

Things you should know...

- 1. The signatory must be registered with ADA. Access will be given to the ADA account that matches the returned Undertaking form.
- 2. You acknowledge that we may need to give your details to the depositor. Depositors may request this information to get an idea about secondary usage for future funding purposes, or to make contact with researchers with similar interests. If this is problematic for you, please contact the Requests Officer to discuss.

Who Signs the Form?

The form can only be signed by someone who can be responsible for the use of the data. For example, a student can be responsible for their own use and could sign their own form, but couldn't sign the form on behalf of a Professor. A Professor, however, can be responsible for his or her student's use, and could sign on behalf of a class.

Conditions of Use

I acknowledge that:

- 1. Use of the material is restricted to use for statistical purposes and that this means that I can only use the material to produce information of a statistical nature. Examples of such uses are:
 - (a) the manipulation of data to produce means, correlations or other descriptive summary measures;
 - (b) the estimation of population characteristics from sample data;
 - (c) the use of data as input to mathematical models and for other types of analyses (e.g. factor analysis); and
 - (d) to provide graphical and pictorial representation of characteristics of the population or sub-sets of the population.
- 2. The material is not to be used for any non-statistical purposes, or for commercial or financial gain without the express written permission of the Australian Data Archive National Manager. Examples of non-statistical purposes are:
